A discussion of my early research into what I named "Strategic Exclusion" (SE): the practice through which queer communities – defined as any marginalized, stigmatized, or non-normative groups – re-define themselves to rhetorically downplay their least normative traits and exclude their least normative members in order to mitigate stigma and pursue acceptance in heteronormative society. The research is focused on the practice as seen in the Furry Fandom, but other examples are also referenced, such as homonormativity.
